



## Aurora Global Income Trust (ASX Code: AIB)

# Performance Report - November 2014

## Summary

- The Trust underperformed the cash benchmark returning -0.3% in November 2014.
- Oil fell 18% in November to a four year low.
- The Earnings Announcement strategy was a drawdown especially for stocks in the Oil and Financial sectors.
- Options positions in Australian banks and consumer staples provided positive returns.

The above composite/hybrid performance summary reflects a combination of the performance of the investment strategy as it applied (net of fees) within the former Aurora Sandringham Global Income Trust (ARSN 131 291 499 - now terminated) since its inception in July 2008 to 30 November 2010, and then the performance of this Trust (which implemented the same strategy) since 30 November 2010 to date. This is not the actual performance of Aurora Global Income Trust (AIB). The actual return of AIB since inception is 2.61% p.a. The table above and the charts below refer to the performance of the composite/hybrid strategy and not of the actual performance of AIB.

#### Investment Objective\*

The Trust aims to achieve absolute returns (i.e. positive returns in both rising and falling equity markets) by using a number of different global investment strategies that allows the performance of the Trust to have very little correlation to the performance of global equity market indexes. The focus on 'absolute returns' differs from traditional funds in that the Trust aims to produce positive returns regardless of equity market conditions.

## **Investment Strategy**

The Investment Manager has a wide discretion over the investments that may be held by the Trust. The pursuit of a diverse range of global investment strategies means that the Trust's returns are not necessarily dependent on any stock markets' direction, or dependent on any specific assumption or key market parameter. The Trust does not seek to replicate the standard industry benchmarks.

The Trust seeks to take advantage of companies that are expected to increase in value relative to the market around the announcement of their quarterly, half-yearly and yearly earnings results, while hedging their market and currency exposure.

In selecting additional investments for the Trust, the Manager follows a rigorous investment selection process which includes detailed qualitative and fundamental research.

The Trust may use derivatives for risk management as well as to create new positions. The Trust may opportunistically short sell securities that are considered to be overpriced in the anticipation of purchasing them later at lower prices for a profit and/or to reduce risk on the overall portfolio.

## Portfolio Commentary

Leading global equity markets were all positive for the month of November except for Australia (S&P500 +2.5%, UK +2.7%, Nikei +6.4% & ASX200 -3.9%). The MSCI World Index (AUD) was up +5.42% although the majority of the increase is currency related and attributed to the falling Aussie Dollar (AUD) versus the US (MSCI USD +2%). Australian domestic cash rates remained unchanged at 2.5% with market expectations now suggesting an interest rate cut in the first half of calendar 2015. Oil continued its slippery slide lower with WTI crude trading below \$US67 per barrel (-18% for the month). This continued to impacted all Energy stocks within the portfolio. The Earnings Announcement strategy produced losses primarily in the Oil & Financial sectors. The Long/Short strategy also suffered due to exposure to materials and energy names. The short-term Options positions in Australian banks and consumer staples contributed positively. Most of the Earnings Announcement positions have now been unwound and will ramp up again in January. In between times the Trust is reviewing opportunities within the additional strategies to target risk-adjusted returns.


